Initial Fee 首次行政費

An initial fee ("Initial Fee" will be charged only once. It is calculated by multiplying (i) the Loan; (ii) the monthly flat rate from time to time applicable to the Eligible Cardholder ("Monthly Flat Rate"); (iii) the number of days from the loan approval date to the first statement date, and dividing the total by 30 days. The Initial Fee will be payable on the first statement date.

一次性收取的首次行政費(「首次行政費」)將於借貸金額交易日(即批核當日)起徵收，並顯示於第一期月結單上。此費用之計算方法如下：
(i)借貸金額乘以(ii)每月平均行政費用率及由(iii)借貸金額交易日至第一期月結單日之日數，除以每月30日。
