

# 「Citi 派利是大抽獎」(「此推廣」)之條款及細則



# Terms and Conditions for "Citi Red Packet Lucky Draw" (the "Promotion")


#### What is the offer?

- 2. This Promotion is only applicable to customers (excluding Citi NextGen Account holders) who hold deposit accounts at Citibank (Hong Kong) Limited and/or Citibank, N.A. (Citibank, N.A., organized under the laws of U.S.A. with limited liability) ("Citi") ("Eligible Citi Customers").
- 3. Eligible Citi Customers can participate in a lucky draw by completing designated missions during the Promotion Period. Winners of the lucky draw ("Lucky Draw Winners") will receive cash reward (as defined in clause 4 below).
