



## **Terms and Conditions of "Citi Payment Message Card Lucky Draw" (the "Promotion")**

### **What is the Promotion?**

1. Unless otherwise specified, the Promotion period is from 3 May to May 31, 2022, both dates inclusive (the "Promotion Period").
2. The Promotion is only applicable to customers of Citibank (Hong Kong) Limited (the "Bank") and eligible customers will be entitled to a lucky draw chance upon fulfilling the following requirements (the "Eligible Client") within the Promotion Period:
  - o Successfully register (once only) for the Promotion via Citi Mobile® App under the "Get More" module within the Promotion Period and conduct at least one eligible transaction via Citi Mobile® App within the Promotion Period. "Eligible transaction" refers to Fast Payment Transfer (FPS), oversea transfers, local transfers to other banks, and bill payments via saving/checking/call deposit accounts (credit card accounts are excluded) only; AND
  - o Set Citi as FPS default receiving bank and remain the setting until August 31, 2022.
3. The Promotion is not applicable to U.S. persons or the European Union (EU) and European Economic Area (EEA) residents.
4. The completion of the registration is not a confirmation of the Reward, which is determined at the sole and absolute discretion of the Bank.

5. Each Eligible Client will be entitled to a maximum of three lucky draw chances (the "Lucky Draw"). Lucky Draw winners will be drawn randomly by the computer. (the "Winner").

12. The English version of these Terms and Conditions shall prevail wherever there is a discrepancy between the English and the Chinese versions.
13. These terms and conditions shall be governed in accordance with the laws of the Hong Kong SAR and the customers irrevocably submit to the non-exclusive jurisdiction of the competent court of the Hong Kong SAR.

## 「Citi自訂轉賬心意卡大抽獎」(「推廣」)之條款及細則：

### 推廣詳情
