



**Terms & Conditions of Citi Credit Card Time Limited Offer for selected customers:**

2. The Promotion is exclusive to selected customers who currently hold banking account with Citibank (Hong Kong) Limited (“Citibank”). For joint banking accounts, only the primary account holder is eligible for the Welcome Offer.
