## Citi Journalistic Excellence Award Celebrates 10 Years in Hong Kong 2019 winner and finalists honored at award ceremony

**Hong Kong** – Citi announced today the winner and finalists of the 2019 Citi Journalistic Excellence Award (CJEA) for Hong Kong. Entering its tenth year in the city, CJEA recognizes outstanding business and financial journalism across markets in which Citi has a presence. The Award was first established in Latin America in 1982 and has been administered by the Columbia University Graduate School of Journalism in New York since launch.

This year sees a record number of entries from financial journalists representing print, online, and broadcast media outlets in Hong Kong. Submissions were judged by independent panels comprising respected academic and business leaders in Hong Kong.

The first round of judging and the compilation of the shortlist were conducted by the senior team at the CUHK School of Journalism and Communication led by school director Prof. Francis Lee. Shortlisted entries were entered to the next round of judging.

Yujing Liu, the Hong Kong winner of CJEA 2019 will join winners from other markets at a five-day seminar administered by the Columbia University Graduate School of Journalism in June.
