



**“Citi Credit Card New Customer Limited-Time Offer - The Peninsula Hong Kong Cake E-Voucher(“ the Reward”)” (“Promotion”) Terms and Conditions :**

1. Unless otherwise specified, the Promotion Period is valid from September 14, 2026 to October 31, 2026 (both dates inclusive) (“Promotion Period”).
2. Customers (“Eligible Cardholders”) must submit the application through the designated links ( <https://www.citibank.com.hk/english/credit-cards> ), Octopus App (the mobile application operated and managed by Octopus Cards Limited (Licence Number: SVF0001), Club HKT Limited’s platform ( <https://www.theclub.com.hk/en/campaigns/citi-the-club-credit-card.html> ), and the “Citi HKTVmall Card Payment Channel” in HKTVmall platform and successfully apply for a principal card of Citi Prestige Card, Citi PremierMiles Card, Citi Cash Back Card, Citi Rewards Mastercard, Citi Octopus Platinum Card, Citi HKTVmall Card or Citi The Club Credit Card (“Eligible Card”) issued by Citibank during the Promotion Period.
