



**Terms & Conditions of "Member-Get-Member Referral Program" (the "Program"):**

1. Unless otherwise specified, the promotion period is valid from July 1, 2026 to January 4, 2027 (both dates inclusive) ("Promotion Period").
2. The Referrer must be an existing principal cardholder of Citi Credit Card issued by Citibank (Hong Kong) Limited ("Citibank") ("Referrer's Credit Card").
3. The Referee must be directly referred by the Referrer and successfully applied for a principal card of Citi Prestige Card, Citi PremierMiles Card, Citi Cash Back Card, Citi Rewards Mastercard, Citi Rewards UnionPay Card, Citi The Club Credit Card, Citi HKTVmall Card or Citi Octopus Platinum Card ("Designated Card") through referrer's Unique Referral Code or Link (defined in clause 5).
